

## Terms and Conditions of Booking – DJ Yorkshire

### **BY PAYING THE DEPOSIT YOU AGREE TO THE TERMS AND CONDITIONS BELOW**

1. Payment should be made in full in advance of the performance date. An invoice will be emailed to you in due course. Should payment not be made as per these terms, DJ Yorkshire reserves the right not to perform its services until payment is received. In this instance, the full amount of the contracted fee will still be due under the terms of the contract.
2. In the event of the performance being cancelled or postponed, DJ Yorkshire retains the deposit paid by the client(s). If the venue or the date is changed, I will honour the deposit where possible. The fee may increase to cover any additional travelling or accommodation costs incurred as a result of the change.
3. DJ Yorkshire provides Public Liability Insurance. A copy of the policy schedule can be provided on request. The cover provided is up to £5 million.
4. In all aspects of the performance, DJ Yorkshire undertakes to act with professionalism and courtesy towards the clients, the venue and the clients' guests. I request that the clients ensure their guests extend the same courtesy on the night. The clients indemnify DJ Yorkshire for any theft of or damage to DJ or computer equipment caused by the actions of guests at the event, where such loss or damage is not covered by my insurance.
5. Set-up and performance times should be confirmed by email or via the music planner at least 14 days before the performance. I understand that flexibility is often required with timings and will endeavour to ensure the smooth running of the event wherever possible. Unless otherwise specified in the booking, the set-up time will be one hour before the commencement of the DJ performance. Additional charges may apply for early set-up, depending on the location and time required. Where possible, this should be agreed in advance.
6. Should the DJ be requested to perform beyond the contracted hours, the additional charge will be £50 per hour or part thereof. This should be paid on the night.
7. DJ Yorkshire may take photographs and short video clips during the event for use on its website and social media channels. These images and videos are used solely for promotional purposes and will always be captured respectfully. If you or any of your guests would prefer that no photographs or videos from your event are shared online, please let me know before the event and I will be happy to respect your wishes.
8. In the unlikely event that DJ Yorkshire is unable to perform due to illness, injury or any other circumstance beyond its reasonable control, every effort will be made to provide a suitable replacement DJ of a similar standard. If a suitable replacement cannot be arranged, all monies paid by the client, including the

deposit, will be refunded in full. DJ Yorkshire's liability will be limited to the total amount paid under the booking agreement.

9. DJ Yorkshire reserves the right to terminate the performance without refund if subjected to verbal or physical abuse, threatening behaviour, unsafe working conditions, or if guests interfere with the DJ or computer equipment. In such circumstances, the performance may be ended immediately and the full contracted fee will remain payable by the client.
